Must also complete Upper Level Legal Writing, Public Service Requirement and Perspective Elective (if enrolled prior to fall 2010). JD students will take all remaining elective courses in their fourth year (if necessary).**

Note: The General JD/MBA is reflected. If a student wishes to add a concentration an additional 12-16 credit hours are required. Please speak with an advisor.

To earn a dual degree students must complete 80 JD semester hours and 60 MBA quarter hours (72-76 with a concentration).
