### STUDENT & PARENT/LEGAL GUARDIAN AGREEMENT AND CODE OF CONDUCT

The undersigned parent/legal guardian (“Parent”) and student (“Student”) have read The Trial Academy’s (“The Academy”) information, and as indicated by their signatures below, agree to the following rules of The Trial Academy. Further, as indicated by the signatures below, Parent and Student release, hold harmless, and indemnify The Academy and the University of Denver, including but not limited to the University of Denver Sturm College of Law (“University”), its officers, directors, agents, employees, partners, sponsors, and affiliates, from and for any claim, injury or other liability of any kind which is caused directly or indirectly by the Student, or which results from or during the Parent or Student’s participation in the Academy. Further, the Academy’s liability for any and all injuries or losses related to or arising from the Student’s participation in the Academy shall be limited to and shall not exceed the tuition actually paid to the Academy.

*I understand that participation in The Trial Academy requires the highest standards of personal conduct and responsibility. Accordingly, I understand and agree to the following rules, regulations and standards of conduct:*

1. I will not use, possess or be under the influence of, any illegal substances, alcohol, or tobacco products at any time during the Academy. I understand that if I use or possess any such substance or product I will be immediately dismissed from the Academy and forfeit all tuition paid.
2. I will not abuse any prescription medications at any time during the Academy.
3. I will not use or possess weapons, of any kind, at any time during the Academy.
4. I will follow the instructions of the Academy and University faculty, staff, and presenters at all times.
5. I will abide by all University and Academy rules and regulations.
6. I will treat all Academy and University faculty, staff, presenters, employees, and all fellow students with courtesy and respect at all times.
7. I will arrive on time and attend all Academy events, including but not limited to, all scheduled classes, presentations, lectures, activities, workshops, projects, etc. in their entirety.
8. I will wear my Academy nametag at all times unless specifically instructed to do otherwise by an Academy faculty member or staff member.
9. I will not leave the Academy or the Academy group at any time during scheduled activities.
10. I am not permitted off campus during the Academy except during scheduled Academy trips or activities.
11. I understand that harassment, sexual harassment, misconduct and/or sexual misconduct is not tolerated in any form at the Academy or by the University.
12. I understand that I am responsible for the facilities of the Academy and the university and I am responsible for repairing and/or replacing any damage or for any excessive clean-up, repair or replacement that may occur to the property of the Academy or the University as a result of my conduct.
13. I understand that I am responsible for my own belongings (including but not limited to money, jewelry, laptops, cameras, cell phones, etc.), and that the University and the Academy are not responsible for damage or loss.
14. I understand that any violation of an Academy or university rule, regulation, or standard of conduct, may result in the immediate dismissal from the Academy at my own expense and forfeiture of all tuition paid. I understand that this decision shall be made at the sole discretion of the Academy staff.
