Dear Judge Jones:

On behalf of Mr. Stockman, we write to request a two-week extension to the motion schedule. Under the current schedule, motions are due January 16, 2008; the government's opposition is due February 12, 2008; and replies are due February 27, 2008. The Court has not yet scheduled oral argument. We respectfully request that the motion schedule be extended so that motions will be due January 30, 2008; opposition February 26, 2008; and replies March 13, 2008. This is the second request for an extension; the first was granted at the October 15, 2008 status conference.

We have spoken to counsel for the government and for Messrs. Stepp and Cosgrove, and they consent to this request. We have also spoken to counsel for Mr. Barnaba, who opposes it because of his pending motion for severance and his statutory and constitutional demand for a speedy trial.
