I confirmed with the DPD Data Analysis unit that due to systems changes, we are unable to produce accurate data for the level of detail on arrest/citation data from 2013. We do not track the issuance of “move on” orders related to offenses other than the Unauthorized Camping ordinance.

Thank you for your response and i appreciate the time taken by yourself and your team to produce this information.

However, I am afraid I must ask for more information as the response is still deficient. We still do not have the data from 2013 for any of the responses. Additionally, we believe that “Street checks” or “move-on orders” are not just issued under the Unauthorized Camping Ordinance 38-86.2 but for the other listed ordinances as per our request. If, in fact, Denver does not either track or issue move on orders under any other ordinance, we would appreciate a response confirming that this is the case.
