 - b. Phil McGrane- Motion to recognize the International Commercial Arbitration Committee
 - i. Cory Hinkle sponsor
 - 1. Competition is basis for Association, largest moot competition in world in Vienna. Association here at DU 5 years ago, student raised all funds by herself to get her to competition. One reason this is important and feels that org needs to be recognized can't enforce a judgment against an international organization. - i. Senator's Reports
 - 1. 1Ls Alan Frosh, constituents pleased with Resolution last week.
 - 2. 2Ls Max Shaffer, speaking to internship contact on how difficult they found it to be working with internship office here at DU. Wanted to bring to Senate's attention. Perhaps that's something that the Senate can get involved in communication gap, hoops to jump through, difficult on mentor's end to get paperwork through.
 - a. Adam seconds. Been difficult to work with.
 - b. Max these problems don't exist at CU.
 - c. Michelle Did internship this past summer for credit, nothing significant with signing paperwork, understand that they're busy. But, practitioner has someone working for free!
 - d. Max Concerned about that, more than just quick signing of forms.
 - e. Katie Heard from a few friends in school that they had a lot of issues getting internships approved, and communication between office and employer regarding professionalism. Upset with process.
 - f. Drew Judge he worked for had problems with turning in paperwork.
 - g. Max will head up effort on how to streamline process.
 - 3. Ben Goff Has been working with Tiffany on getting massage and wellness kits going. 1:30 4:30 on 12/2, Tuesday for massage appointments. Will also have table set up in forum with Wellness Kits, may need help setting up, will circulate signups.
 - a. John C only day? Yes, for now.
 - b. Ben Let's make sure time is well used. Masseurs need practicum hours.
 - 4. Phil We have new copier. As soon as we can, definitely move printer, provide enough paper for monthly allocation.
 - a. Jon K Dave Dudra is trying to work on transition.
 Technology is in place, just need to finish set up.
 Should be happening soon. Phil volunteers to meet with Tech Services on how to use copier. Hasn't been worked out how to load share the paper yet.
 SBA shouldn't be paying for everyone's use of the paper we don't fund law reviews.
 - 5. Darryl Had a few evening students who are graduating early, concerned that required courses aren't offered every semester in the evening.

- Katie Aren't enough of the required courses.
 Heard a lot of complaints since registration has started.
- Jon K Response from administration is that professors are the ones who weigh in on when they will teach classes. Tough for administration to dictate class times.
- c. Ben Very few classes after 1st year that are 4 credits. Work load seems similar. But feels like students don't have a lot of leverage with Registrar.
- d. Jon K Maybe something we think about it as a Senate. Develop rapport with Registrar, maybe get to a point where we do have leverage. They do deal with a lot of scheduling, but taking small steps with Registrar is where it would start.
 - i. Darryl Students/faculty is give and take relationship. Need to work on some type of system for voicing concerns with Registrar.
 - ii. Linda Has had conversations with Dean Bryan in past about scheduling issues. Really depends on professors, who wants to teach, who can teach, and then build schedule around that. Goal is to not have class cancelled. Balance within the school. Has waitlisted a lot of classes, but can usually get in. Registrar will start to look at it and see if they can move room to get everyone in. Chances are good if you waitlist.
- 6. Cody Faust Evening student, speaker attendance. Would like to run idea by Senate. Idea is that we require orgs to video record meeting, archive video on respective sites online. Downfall is evening students not being able to ask questions, but could email orgs ahead of time with any questions.
 - a. Jon K Good idea. If you know you can have your event in a room that's capable of recording and tech services can assist you, this is something the Senate should consider to repair rift between day and evening students.
 - b. Alan Recording could be seen as a slap in the face to some.
 - c. Jon K maybe look at this some more next semester, have finance committee consider asking orgs about this.
