## **Denver Law Student Wins Baylor Law's The Closer Competition!**

Did you know that 3L, Ryann Patton Connell, won Baylor Law's *The Closer* Competition, which was held January January 13-16, 2023.

Ryann received the problem Friday morning where she was tasked with representing two local developers in their new food hall venture to negotiate an economic development agreement with the city. She had 24 hours to prepare (with her coach) to negotiate with the city's representative on Saturday. After four negotiation rounds on Saturday, Ryann was one of four student participants (two from each side of the transaction) selected to advance to the Sunday final rounds where she negotiated in front of five judges and a room full of observers.
