### SALARY INFORMATION

Information is based on full-time salaries that were reported or publicly available.

#### ALL REPORTED FULL-TIME SALARIES

Our salary statistics are based on obtaining full-time salaries from 71% of the class, which were reported or publicly available.

#### PRIVATE SECTOR

This includes positions in law firms, business, and industry (based on the 94 known salaries reported or publicly available for graduates employed in the private sector, which represents 39% of the class.

Equation: 94 known salaries divided by 243 JD graduates in the class = 39% of the class

#### PUBLIC SERVICE

This includes government positions, judicial clerkships, academic posts, or positions with non-profit advocacy or cause-oriented organizations (based on the 78 salaries reported or publicly available for graduates employed in public service, which represents 32% of the class.

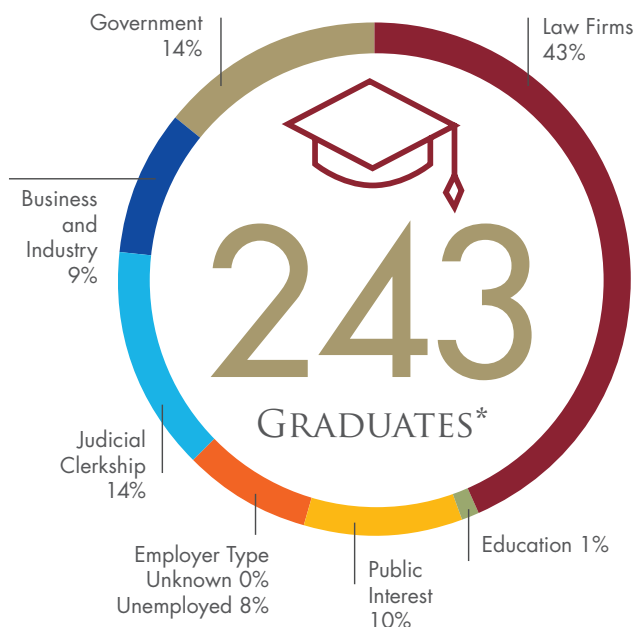
Equation: 78 known public sector salaries divided by 243 JD graduates in the class = 32% of the class

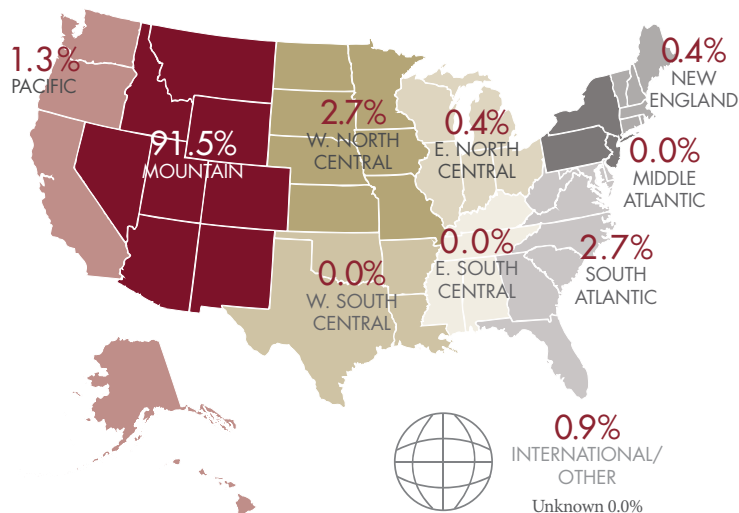

<sup>\*\*</sup>While we ask all graduates who are employed in full-time positions to provide their salaries, salary information is more difficult to obtain than employment status. Of the 243 graduates, 241 sought employment of which 222 (92.1%) are employed in professional positions.

Of the 243 Graduates, 91.8% are employed, 8.2% are unemployed. Please note that the number of employed graduates includes a number of law school funded positions.

The 8.2% unemployed comprise of 20 individuals: 18 seeking employment, 1 non-seeking employment, 0 Employment Start Date Deferred, 0 Undeterminable, 1 Seeking Graduate Degree.

<sup>1</sup>Additional fees not included in the above cost of attendance include: Loan Repayment Assistance Program Fee - \$90 (first semester only), Health & Counseling Fee (optional) - \$600.

<sup>2</sup>Health insurance is required to attend Denver Law; you can waive the university's coverage if you have your own. The cost above is for 12 months of coverage (Aug. 1 to July 31).

<sup>3</sup>An origination fee is deducted from all disbursements of Direct Unsubsidized (1.057% fee) and Graduate PLUS Loans (4.228% fee). The amount above is the average fee paid by students borrowing an Unsubsidized Loan. Actual fees will vary based on amount borrowed.

## FINANCIAL AID AVAILABLE

**Scholarships:** All scholarship aid awarded by Denver Law is merit-based. We do not award need-based grants. Scholarships range from \$19,000 to full-tuition for full-time students and \$14,250 to full-tuition for part-time students and are renewable provided you maintain a 3.0 cumulative GPA. All students are automatically considered for most merit aid. Scholarships are awarded on a rolling basis until funds are exhausted, so apply early to ensure that funds are available.

**Chancellor's Scholarship:** The Chancellor's Scholarship is the one scholarship for which you must apply. This full-tuition scholarship is awarded to students with a history of excellence in academics and public service who intend to pursue public interest law careers. To be considered, you must apply on our website by **February 15th**.

**Federal Financial Aid:** Federal grant aid is not available to law students. Nearly all federal aid that is awarded is in the form of federally guaranteed loans. To be considered for federal aid, you must file the FAFSA annually at [www.fafsa.gov](http://www.fafsa.gov). The priority deadline to file your FAFSA is January 15. The following federal financial aid is available at Denver Law: Direct Unsubsidized Loans, Direct Graduate PLUS loans and Federal Work Study.

**Military Benefits/Yellow Ribbon Program:** Military benefits can be used at Denver Law and we do participate in the Yellow Ribbon Program. The Post - 9/11 GI Bill provides for up to \$25,162.14 in tuition/fees assistance for the 2020-21 academic year. Additionally, those eligible for 100% of their benefits under the Post - 9/11 GI Bill are also eligible for funding through the Yellow Ribbon Program, which, at DU, provides students with up to an additional \$10,000 in tuition/fee assistance.
