

Denver Law will offer a range of competitive stipends to support unpaid work with nonprofits and governmental agencies during Summer 2021. Denver Law appreciates your willingness to contribute the public good and we want to do our best to support your efforts. We also advertise and, provide support for, national summer funding programs. For all stipends listed below, you are eligible to receive credit simultaneously, provided your supervisor is approved. Please also note that there are different deadlines for each stipend below.

Summer Funding for Public Interest Work for Only DU students

- **Denver Law Summer Stipends (Amount TBD):** Denver Law provides funding to students who are working in a legal placement with a nonprofit, government agency, or judicial chambers. In determining awardees, the committee will consider and prioritize the following: timely and thoughtful completion of the application, whether applicants are receiving any other funding; any extraordinary costs associated with the summer/placement; applicants' demonstrated commitment to the public good, applicants' whose work is in the nonprofit setting; and applicants' whose work is on behalf of economically disadvantaged or underrepresented clients, groups, or organizations. The number of awards and amount of each award is yet to be determined. - **Squire Patton Boggs Foundation Fellowship (\$2500):** This is for students engaging in public policy work for either a nonprofit or government agency. You cannot engage in litigation, trial work, or client representation. Two awards will be given. Applications are submitted through Symplicity, #24006. Deadline: **March 19, 2021.**
- **Hill and Robbins Fellowship with Colorado Legal Services (\$5K, 1 award to CU/DU):** The Fellow will work with Colorado Legal Services through some or all of the following responsibilities: preparation of draft pleadings, strategizing on policy work with administrative agencies, legal research, case organization and investigation, client interviews, and client communication. The first portion is 100 hours of work during Spring semester 2021. The second phase is full-time work for ten weeks during summer 2021. If necessary, the Fellowship can be performed entirely during summer. Submit cover letter, resume, and one to three written recommendations concerning the applicant's research and writing skills, and suitability for the position to matthewmontgomery@hillandrobbins.com. Deadline: **Feb. 26, 2021.**
- **Sattler Civil Rights Fellowship (\$5K, 1 award to CU/DU):** The Fellow will work at the Colorado Lawyers Committee for 10 weeks. The Fellowship offers a unique opportunity to work with a variety of lawyers on high impact, pro bono matters and to gain insight into all aspects of the pro bono legal community in Colorado, primarily in Denver. - **Ved Nanda Center Summer Stipends: (\$500-\$1500 generally):** The Ved Nanda Center at Denver Law provides funds for stipends to students working or externing in the area of human rights. Students submit their resume, information on the job/internship, and a cost estimate in support of their funding request to aaguirre@law.du.edu. Summer Funding for Public Interest Work, open to all law students:

- **Rural Summer Legal Corps: Paid Civil Legal Services (\$5K).** This program places 25 students at LSC-funded civil legal aid organizations in rural areas across the country. Selected Student Fellows must work 300 hours during summer 2021 over 8-10 weeks. - **Disaster Resilience Fellows: Paid Civil Legal Services (\$5K).** This program places 6 students at nonprofits to provide free civil legal aid in disaster-prone areas alongside lawyer fellows. [Click here](#) to apply. Deadline: **Feb. 16, 2021.**

- [2021 TFAS Summer Law Fellowship](#): This is a nine-week program that aims to prepare law students to defend the values and ideals of a free society rooted in individual liberty, limited government, free enterprise and constitutional originalism. Those selected to participate receive a full scholarship covering tuition, housing and program fee
