Still pondering class options, consider registering for these courses taught by some of our stellar adjuncts:

Asset Management Regulation focuses on the evolving and increasingly important regulation of the investment management industry in which some 13,000 SEC-registered investment advisers manage more than \$25 trillion in assets in the U.S. alone. This legal growth area generates many interesting employment opportunities for lawyers which will be highlighted throughout the semester including with guest speakers.

**Corporate Transactions Practicum** examines complex commercial transactions from a variety of angles. Students will work in buyer and seller teams to navigate and negotiate actual transactions. This class offers a great opportunity for students looking for a real world complex commercial deal experience.

**Taxation of Business Entities** focuses on the fundamental concepts regarding the three tax regimes that apply to business entities with a legal identity separate from their individual owners (C Corporations, S Corporations, and Partnerships). Students will leave class with a basic understanding of the taxation of these three tax regimes and the ability to compare and issue spot the tax consequences of choosing between them.

# Denver Law Hosts Online Transactional LawMeets Competition

Denver Law partnered with the UMKC School of Law to host 24 teams from across the US at a virtual Transactional LawMeet<sup>®</sup> Competition on Friday, March 26.

This years' experience was centered on an acquisition of a pharmaceutical company where students were asked to negotiate an amendment to the stock purchase agreement after unforeseeable circumstances arose after execution of the agreement, but prior to closing of the merger transaction.

The Denver Law team was comprised of Anthony Gunnell, Bradley Scoble, and Van Vu, all 3Ls. Over a two-month period, the team took on the role of counsel for the buyer in the transaction. The students interviewed their client, drafted an amendment to the existing stock purchase agreement, and marked up an opposing team's amendment. On March 26th in the UMKC region, the Denver Law team participated in two negotiation rounds against teams from University of Arizona and NOVA Southeastern University, both of which represented the seller in the transaction. Each round was judged by two practicing attorneys from the greater Kansas City area.

Throughout the competition, Denver Law alums who are local transactional law practitioners and former LawMeet® participants acted as coaches for the team by brainstorming ideas and reviewing documents. The team met via Zoom or communicated weekly with their coaches. The team noted that "they worked well together as each member brought a different a different strength and skill set to the team, ranging from a high level as well as an in-depth understanding of the transaction, to detail-oriented drafting, to organization." The team also shared that they had a cohesive work dynamic and stated that "it was a fun learning experience for all the team members and they continued to build skills that will propel them forward in their transactional law careers after graduation." One of the negotiation round judges joked, "you guys did such a great job. I hope I won't have to negotiate against you anytime soon!"

The Denver Law team was a tough competitor and was named the overall winning team representing the buyer in the transaction in the UMKC region. One of their opposing counsel, the team from the University of Arizona, was named the overall winning team representing the seller.
