

The Number of Systems Continues to Grow




Average trip for members

LICENSE AND INSURANCE REQUIREMENTS

The permit holder shall maintain a Commercial Property Insurance Policy on the premises during the term of this agreement. The required insurance shall be paid by the permit holder. Prior to commencement of this agreement, the permit holder and its subcontractors shall provide a certificate of insurance evidencing the following coverages:

Commercial General Liability Insurance. During the term of this agreement, the permit holder and its subcontractors shall provide general liability coverage against claims arising out of bodily injury, death, damage to or destruction of the property of others, including loss of use thereof, and including products and completed operations in an amount not less than One Million Dollars (\$1,000,000.00) per occurrence and Two Million Dollars (\$2,000,000.00) general aggregate.

All the above must be verified, fees paid, and the following documents attached with the application prior to permit issuance:

- a. Insurance & Indemnification documentation
- Images and description of bicycles and mobile application
- Size of fleet, including any planned fleet expansion over year
- Service area, including any planned area expansion over year
- Education and outreach plan for proper bicycle parking and riding
- f. Plan to provide an equitable bicycle share service to service area




The city of Aurora launched a Bike Share Permit Program in late 2017 to increase mobility options for its residents. Aurora was the first city in Colorado to host dockless bike sharing.

What is bike share?

Bike share allows anyone to rent a bike to travel from one destination to the next. Many bike systems worldwide operate as a docked system where bikes must be checked out from and returned to a fixed docking station. A new dockless bike sharing system allows bikes to be picked up and parked anywhere, as long as they are parked legally and accessible to others.

How does bike share work in Aurora?

Private bike share companies obtain a permit to operate in Aurora, and supply and maintain the bikes; the program is not supported by any city capital investment. Anyone may use the bikes by downloading the bike share company's application on your smart phone.







Chinese bike share graveyard a monument to industry's 'arrogance'

Future of dockless bicycles under a cloud amid concerns there are too many bikes and not enough demand



At first glance the photos vaguely resemble a painting. On closer inspection it might be a giant sculpture or some other art project. But in reality it is a mangled pile of bicycles covering an area roughly the size of a football pitch, and so high that cranes are needed to reach the top; cast-offs from the boom and bust of China's bike sharing industry.

Just two days after China's number three bike sharing company went bankrupt, a photographer in the south-eastern city of Xiamen captured a bicycle graveyard where thousands have been laid to rest. The pile clearly contains thousands of bikes from each of the top three companies, Mobike, Ofo and the now-defunct Bluegogo.
