### Courses of Record

#### Legal Analysis Strategies

***Spring 2026; Spring 2025; Spring 2024; Spring 2023; Fall 2022; Fall 2021; Spring 2021; Spring 2020;***

This course provides students in their last semester of law school with instruction, practice, and feedback in legal analysis, problem-solving, and communication skills by simulating problems that students will encounter on the bar exam and as lawyers. The purpose of LAS is to enhance learning, analytical, and communication abilities within a framework of educational psychology strategies and core substantive areas to provide a strong foundation for bar exam preparation and performance.

#### Developing the Lawyer Externship Seminar

***Synchronous Format - Summer 2021; Asynchronous Format - Spring 2021***

This seminar is designed for individuals with at least 1-2 years of professional work experience prior to law school. This seminar focuses on the skills, competencies, and values students bring with them and how they apply to the legal profession within their externship placement as they begin formation of a new professional identity. This identity transformation focus is grounded in each student choosing a biography/memoir/autobiography of an aspirational attorney to read and use as context for their own development throughout the semester.

#### Fundamental Lawyering Skills Externship Seminar

***Synchronous Online Format - Summer 2021; Spring 2021; Fall 2020; Summer 2020***

This seminar will focus on the values and skills necessary to succeed in legal practice, whether your client is a private individual, an organization, the government, or the public at-large. We will reflect on these values and navigate the development of your own identity as a lawyer to inform your current field experience and promote your entrance into the legal profession.

#### Externship Field Credit – Summer 2021; Spring 2021, Fall 2020, Summer 2020

Students are supervised by externship program faculty supervisor through reflective-based assignments throughout the semester in addition to required individual meetings with their faculty supervisor.

### University of Idaho College of Law

*Assistant Clinical Professor of Law for Bar Success*

Aug 2021 – Aug 2023

- Instruct 2-3 courses per year in Advanced Legal Reasoning focused on legal problem-solving in the bar exam context.
- Direct and instruct a post-graduate bar exam success program to teach learning strategies, review bar exam substantive topics, and guide experiential practice.
- Meet with unsuccessful examinees to dissect scores and issues with the prior exam performance and coach to successful strategies for repeat attempts.
- Provide counseling and individual coaching to over 100 students each year regarding their bar exam study habits, barriers, and overall study approach.
- Review and provide constructive feedback to students on essay and performance test writing assignments

### Courses of Record

#### Applied Legal Reasoning

***Spring 2022; Spring 2023***

Training in the analytical, writing, and organizational skills needed to efficiently analyze legal questions under time pressure and prepare for the bar exam. Using 2–3 doctrinal subjects, students apply critical reading, issue spotting, organizational, and writing skills to multiple-choice, essay, and performance problems. Open only to students in their last year of law school. Graded pass/fail.
